3. How We Use Your Information

We process your data to:

- Provide, operate, and maintain our services
 - Process transactions, payments, and license delivery
 - Manage Contributor accounts and royalty payments
 - Communicate updates, support responses, and service messages
 - Improve website functionality and user experience
 - Detect and prevent fraud or misuse
 - Comply with legal obligations and enforce our Terms & Conditions

4. Legal Basis for Processing (GDPR-Compliant)

We rely on the following legal bases:

- **Consent** – When you voluntarily provide information
- **Contractual Necessity** – To deliver purchased content or manage Contributor royalties
